Sealed tenders are invited from intending manufacturer /distributer/stockist/ wholesaler for supply of medical teaching instruments to SJMedical College & Hospital, Puri. The tender documents should reach the office of the undersigned by 4PM,16.08.2022 through registered post /Speed post only which will be opened on17.08.2022 at 4pm in the office chamber of the Superintendent, SJ Medical College & Hospital, Puri.

- 1. The tenderers shall submit the tender documents in two bid system: technical bid & financial bid in sealed envelopes super scribed as technical bid(Cover-A) and finance bid superscribed as finance bid (Cover-B) which will be kept inside a single sealed envelope superscribed as "Tender for supply of Medical "Teaching Instruments" on its top.
- 2. The tenderers have to submit the following documents along with the tender paper Technical Bid (Cover-A)
- (i) Self attested photo Copy of IT returns for last 3 (Three) financial years i.e 2018-19,2019-20 & 2020-21
- (ii) Self attested Copy of Pan Card.
- (iii) Original money receipt against purchase of tender paper/DD worth Rs.1000/-(one Thousand only) towards tender paper cost.
- (iv) Attested photo copy of Registration Certificate registered under GST.
- (v) An under taking showing the quoted prices are not more than the prevailing market price / MRP
- (vi) Account payee DD worth Rs. 10,000/- (Ten thousand) towards the cost of EMD.

Name of the items & TECHNICAL SPECIFICATIONS

1.BANDSAW

- Width/Depth/Height: 900 x 600 x 1500 mm
- Working height approx.900 mm
- Cut height max. 210 mm
- Cut width max.350mm
- Should comply with Safety standard EN 13849-1
- ➤ Band speed about 200–1200 m/min
- For precise alignment and guidance, should have Line laser for cut orientation, parallel stop Should have LED light strip provides optimal illumination of the work space
- Should have Water jet cleaner to effortlessly remove tissue residues from the work table while working.
- Extended spray containment cabinet over the entire work space provides additional safety

2. ORIGINAL HUMAN SKELETON (ARTICULATED)

Original human bones, from single source, articulated scientifically as per the placement of the bones in the human body. Proper synthetic materials must have been put in the joint spaces. It must be certified by an Anatomist.

Note: The original human skeleton supplier has to furnish license or permission issued by the Govt. Statutory body and has to furnish authorization to the bidder to submit bid and quote in the tender, however sole authorization is not applicable for this item.

3. ORIGINAL HUMAN SKELETON (DIS-ARTICULATED)

Original human bones, from single source, dis-articulated scientifically as per the placement of the bones in the human body with colors of the muscles. Proper synthetic materials must have been put in the joint spaces. It must be certified by an Anatomist.

Note: The original human skeleton supplier has to furnish license or permission issued by the Govt. Statutory body and has to furnish authorization to the bidder to submit bid and quote in the tender, however sole authorization is not applicable for this item.

4. EMBALMING MACHINE

- 1. Manufacturer should be ISO certified.
- 2. Embalming machine with its specialized noise less pump, provide suction and delivery at optimum pressure with a fluid delivery rate of 10Litres/hr with salient features such as SS Inner tank to store fluid capacity 10-15 liters.
- 3. Should be fitted with rotary compressor suitable for embalming the cadaver with stellate and required needle



- 3. Should be fitted with rotary compressor suitable for embalming the cadaver with stellate and required needle
- 4. Should be mounted on castors for easy movement and grips provided for lifting
- 5. Should have IV stand fixed for mounting cannula tubing and mains cable with Mains-on and in use indication.
- 6. Should be complete stainless steel outer body and Cadaverous injector for injecting formaldehyde solution in Cadaverous at much higher speed than normal gravity process. Unit should be fully covered and mounted on a portable trolley having four castor wheels for easy movement.

7. Unit should consist of one air compressor fitted with 1/2hp motor which is connected with a stainless steel tank of 10 liters capacity meant for storing and injecting the solution.

8. Tank should be fitted with a safety valve, pressure gauge and rubber tubing having provision for injection and supplied complete with electric cord, plug and suitable to work on 220V, 1ph 50hz, AC supply.



TERMS & CONDITIONS

- 1. The tenderer should be a registered firm under GST.
- 2. The quoted rates should be exclusive of all taxes and HSN code should be mentioned against each quoted instruments.
- **3.** The delivery of the instruments should be made possitively within 7 working days from the issue of purchase order.
- 4. Any conditional tender will not be accepted.
- 5. No advance payment will be made against execution of order, the required instruments are to be procured in credit basis against different orders and payment will be made on submission bills in triplicate to the undersigned. The authority will not liable for delay in payment in an unavoidable circumstance like paucity of funds etc.
- 6. The rate should be valid up to one (1) year from the date of finalization of the tender.
- 7. The tenderers should depute a technical person for demonstration of instruments with specification before the members of selection committee whenever necessary.
- 8. No Tenderer beyond the stipulated date & time will be accepted & Tenders without EMD will not be considered.
- 9. EMD of successful tenderer will remain with the undersigned till expiry of valid period of the tender and the unsuccessful bidders can take back their EMD on submission of an application to the Dean & Principal SJMCH, Puri seeking for so.
- 10. Original documents may be produced for verification if asked for.
- 11. If any information/documents furnished by the tenderers with the tender paper are found to be misleading or incorrect at any stage their tenders will be cancelled.
- 12. The authority reserves the right to cancel/reject the tender process at any stage without assigning any reason thereof.
