RECRUITMENT OF SENIOR RESIDENTS, TUTORS, AND JUNIOR RESIDENTS AT SJMCH, PURI ON CONTRACTUAL / DEPUTATION BASIS UNDER HEALTH & FAMILY WELFARE DEPT, GOVERNMENT OF ODISHA

Consequent to Notification No. HFW-MEI-SR-0002-2018-1532/H Dated 19/01/2024 and in view of NMC urgency, eligible candidates will be engaged in the Posts of Senior Resident/Tutor/Junior Resident at SJMCH, Puri on contractual/deputation basis through Walk-in-Interview on 12.02.2024 in the Office of Dean & Principal, SJMCH, Puri. The details of Eligibility Criteria/ Vacancies/ etc. are as under. The Direct candidates shall be appointed on Contractual Basis and the In-Service candidates shall be appointed on Deputation Basis. The candidates who are continuing as Senior Resident/Tutor/Junior Resident in any of the Govt. Medical College of the State, VIMSAR, Burla or AHPGIC, Cuttack, are not eligible to apply. The Senior Resident/Tutor/Junior Resident whose tenure is terminated for any adverse reason by the appointing authority will be debarred from being selected for a period of next three years.

I. ELIGIBILITY QUALIFICATION:

The candidate must be a citizen of India.

A. <u>SENIOR RESIDENT/TUTORS in Pre-Clinical/Para-Clinical Departments (as per Govt of Odisha, Health & Family Welfare Department Resolution No HFW-MEI-SR-0002-2018, 18582/H&FW, dated 13-08-20)</u>

Academic qualification:

- 1. MBBS is the basic qualification.
- However, first preference will be given to the candidates having Post Graduate Degree in concerned discipline and candidates with MBBS degree can only be considered if no MD/MS/DNB candidates are available in any category of the said discipline.
- If enough PG Degree candidates followed by MBBS qualified candidates are not available, the candidates having M. Sc. Degree on regular on campus course in Medical Anatomy, Medical Physiology & Medical Bio-chemistry along with any other additional qualification

- as may be prescribed by MCI/NMC shall also be considered in the concerned disciplines only. However, MBBS candidates shall be preferred to M.Sc. candidates.
- 4. MBBS candidates can apply for Tutor in more than one discipline in pre and para clinical subjects using separate application form and fee for each discipline. The candidates who are continuing as Post PG bond service are entitled for teaching experience certificate as SR for two years and hence shall not apply.
- The engagement shall be purely temporary and on year-to-year tenure basis and is for a period of maximum three years

Other Conditions:

a) The posts are non-practicing.

B JUNIOR RESIDENT

Academic qualification

- A candidate must possess a MBBS degree (for medical stream) or equivalent degree recognized by MCI/NMC.
- 2. The candidate must have completed the compulsory one-year rotating internship.
- The candidates must have registered their Medical Qualification at Central/State Medical Council. (Permanent Registration).
- 4. The above qualifications must have been obtained on or before the date of counseling.
- The engagement shall be purely temporary for a period of one year which may be extended on year-to-year basis for maximum period of 3 years subject to satisfactory performance.
- Candidates having post-graduate degree in any discipline or are continuing or have completed
 a three years tenure as Senior Resident/Tutor/Junior resident in any MCI/NMC Permitted/
 Approved/ Recognized institutions are not eligible to apply.
- The candidates will be paid consolidated amount of Rs. 65,000/- (Rupees Sixty-Five Thousand only) per month. Any additional incentive declared by the Government of Odisha for these Posts shall also be applicable.
- The appointment shall be made as per the terms & conditions / Job responsibilities envisaged in Government Resolution No.18582/ H &FW dt.13.08.2020.

Other Conditions:

a) The posts are non-practicing

II. AGE LIMIT

- a. For Senior Residents/Tutor: The upper age limit must be less than 45 years as on the date of joining in the post for SR/Tutor.
- For Junior Residents: The upper age limit shall be less than 70 years as on date of interview.

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

III. SALARY/ CONSOLIDATED PAY

- a. The Direct Senior Resident/Tutors will be paid a consolidated amount of Rs. 65, 000/-(Rupees Sixty-five Thousand only) per month.
- b. The Junior Resident will be paid a consolidated amount of Rs. 65,000/- (Rupees Sixty-five thousand only) per month.
- c. The In-Service Candidates shall be allowed salary at par to the post in which appointed and any incentive as may be notified by Govt. It will be guided as per the Govt letter No. 9684/H Dt 02.05.2022.
- d. Any additional incentive declared by the Government of Odisha for these posts shall also be applicable.

IV. ENGAGEMENT PERIOD

- a. For contractual direct candidates (Senior Resident/Tutor) the engagement shall be purely temporary and on year-to-year tenure basis and may be for a period of maximum three years subject to requirement and satisfactory performance.
- b. For Junior Resident engagement shall be purely temporary and on year-to-year tenure basis and may be for a period of maximum three years subject to requirement and satisfactory performance
- However, the Govt. reserves the right to terminate the services of the /SR/Tutor/JR with one-month prior notice from either side

V. AVAILABLE VACANCY

The vacancy is provisional and is subject to change as on the date of counseling. Vacancies occurring after the date of counseling shall be filled up through fresh advertisement. The **Vacancy Position** is mentioned below.

VI. PROCEDURE OF APPLICATION

Candidates shall download the Application Form annexed in this Advertisement from www.sjmch.odisha.gov.in. Eligible candidates shall appear personally before the Dean & Principal, SJMCH, Puri on 12.02.2024 at 11.00 AM and submit the Filled-In Application Form (attached to this advertisement) and Photocopy of Required Documents and Color Passport Photograph. They must bring the Original Documents for verification. A Recruitment Fee of Rs. 500/- is to be given as Demand Draft in favour of 'Dean & Principal, SJMCH, Puri', payable at Puri. The application fees is not refundable at any circumstances.

After successful verification of the documents during the Walk-In-Interview, a **Merit List** shall be prepared and notified on **13.01.24**. Any other information shall be notified by the Convener in the website of SJMCH, Puri <u>www.sjmch.odisha.gov.in</u>.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification /counseling / choice filling physical presence of the candidate is mandatory and no authorization will be entertained

VII. PROCEDURE OF SELECTION

7.1 <u>Senior Residents (Medical Postgraduates)/Tutor (MBBS, Non-medical Postgraduate)</u>

- a. The selection for Senior resident/Tutor shall be as under:
- Selection will be strictly on the basis of merit list prepared on basis of career marks.
 Weightage for different examinations shall be as under:

HSC/Matriculation- 20% of total percentage of marks secured.

Intermediate Science- 20% of total percentage of marks secured.

MBBS examination/MSc- 60% of total percentage of marks secured.

- One mark will be deducted from the total Career Mark for each extra attempt taken to pass the examinations.
- iii. In the case of foreign medical graduates (FMG) the marks secured in the subjects as per the NMC/MCI/DCI conducted by NBE shall be taken for calculation of merit as above. Where the candidate does not submit such mark sheet, their marks will be taken as 50%.
- b. In case of tie it will be resolved as follows:
 - 1)The candidate securing more mark in MBBS shall be placed in higher rank.
 - 2)In case of further tie, the elderly candidates shall be placed higher in rank to the younger.
- c. The Selection Authority at their discretion may short-list the merit list to a reasonable number as per available vacancy.
- d. The candidate has to join within 7 days from the issuing of joining order.
- e. In case the candidate appointed fails to join in time, then the next candidate in the panel for the subject may be given a chance.
- f. Any clarification / corrigendum / addendum to this advertisement if required shall be issued by the Dean and Principal, SJMCH and shall be final and binding and will be a part of the advertisement.

7.2 Junior Resident

- a. The selection for Junior resident shall be as under:
- i. Selection will be strictly based on merit list prepared on basis of career marks. Weightage for different examinations shall be as under:

HSC/Matriculation- 20% of total Percentage of marks secured.

Intermediate Science- 20% of total Percentage of marks secured.

MBBS examination- 60% of total Percentage of marks secured.

- One Percentage mark will be deducted for each extra chance in the concerned subject while calculating the aggregate Percentage of MBBS.
- iii. In the case of foreign medical graduates (FMG) the marks secured in the subjects as per the NMC/MCI/DCI conducted by NBE shall be taken for calculation of merit as above. Where the candidate does not submit such mark sheet, their marks will be taken as 50%.
- b. In case of a tie, it will be resolved as follows:
 - 1. The candidates securing more marks in MBBS shall be placed in the higher rank.
 - 2. In case of a further tie, the elderly candidates shall be placed higher in rank to the younger.
- c. The Selection Authority at their discretion may short-list the merit list to a reasonable number as per available vacancy.
- d. The candidate has to join within 7 days from the issuing of joining order.
- e. In case the candidate appointed, fails to join in time, then the next candidate in the panel for the subject may be given a chance.
- f. Any clarification / corrigendum / addendum to this advertisement if required shall be issued by the Dean and Principal, SJMCH and shall be final and binding and will be a part of the advertisement.
